Racers are responsible for their own points and to verify their correctness. It is a racer's responsibility to notify the tower if a competition number is incorrect on their time slip as soon as possible so the appropriate points will be awarded.

Points are awarded on the basis of rounds won, not rounds staged.

Show points are awarded to those who stage for at least one (1) time trial. First round attendance is not necessary.

End of Season Tie Breaker- (Tie breakers do NOT add points to the final year total. It is only used to determine the placement order of the tied individuals.)

In the event of a tie, in order to break the tie, the following will be done-

-One (1) point will be awarded to the competitor with the highest attendance for points days.

If that fails to break the tie, then;

-One (1) point will be awarded to each competitor for each final round win in their category.

If that fails to break the tie, then;

-One (1) point will be awarded to each competitor for each final round runner-up in their category.

If that fails to break the tie, then;

-Best qualifier at the final race, or in the case of a non-laddered category, best reaction time during the last time trial will be awarded one (1) point.

\*\*In the case of multiple ties, the Best qualifier at the final race, or in the case of a non-laddered category, order will be determined by best reaction to worst in the final time trial of the last points race.

\*Bikes in the Valley- The number one (#1) qualifier receives one (1) additional point.
