



LEBANON VALLEY DRAGWAY PHOTO AND VIDEO AGREEMENT PLEASE READ THOROUGHLY – THIS IS A LEGAL AGREEMENT

AGREEMENT: Each photographer/videographer must sign this Lebanon Valley Dragway photo and video agreement as well as the official insurance release and waiver to be granted access to shoot photography and/or video at any event.

By signing below, you are accepting and agreeing to the terms of this agreement and accept the grant of a one-time limited license by Lebanon Valley Dragway to enter our premises and shoot photography and/or video at a Lebanon Valley Dragway event. **In exchange for photo/video access to this event I hereby agree that I will be publishing event editorial coverage of this event.** Lebanon Valley Dragway reserves the right to grant or take away photography and/or video access at any event for any reason at any time.

Use and reuse of all images and/or video is governed by this Lebanon Valley Dragway photo and video agreement. Nothing herein constitutes a license to use Lebanon Valley Dragway marks or the marks of third parties, or authorizes you to use the name, image, or likeness of any recognizable person, whether a participant in the race or a spectator.

RESPONSIBILITY TO COMPLY WITH CURRENT PHOTO/VIDEO POLICY:

In order to facilitate trackside access (not starting line), photographers and videographers are required to confirm whether there have been any changes to Lebanon Valley Dragway photo/video policy in advance of each event he/she attends. By signing this agreement you agree to comply with all Lebanon Valley Dragway photo/video policies including any modifications made by Lebanon Valley Dragway thereto, which modifications will be available from the track manager or assistant manager prior to and during all events.

Lebanon Valley Dragway has a legally-binding, exclusive agreement with a third party video producer which permits it to sell videos of the event on an exclusive basis. *This agreement also forbids use of video footage in any way that could be competitive with those videos.* In addition, the agreement provides that, if requested, you are required to provide a duplicate master of all of the footage you take at and/or of the event. All or part of your footage may be used by Lebanon Valley Dragway or the third party for any and all purposes, for no compensation or credit to you. **There are NO exceptions to this rule.**

Lebanon Valley Dragway has a legally-binding, exclusive event photo agreement with a photo vendor (OnPoint Image) to exclusively sell photos to Lebanon Valley Dragway racers, sponsors and fans. *No other person may sell or give-away photos and/or video at this or any event or after the completion of this or any event.* **There are NO exceptions to this rule.**

I agree that absolutely no photography and/or video will be sold or given away to any Lebanon Valley Dragway racers, sponsors or fans during this event or after. _____

High resolution images may never be posted online. Only low resolution images may be published if they are included with comprehensive editorial coverage. Photo gallery postings (multiple image groups) may not be posted online larger than 900 pixels wide. _____

Video Only - I agree that if I am asked, I will deliver a duplicate master of all the footage I take at the event to Lebanon Valley Dragway within 10 days of receiving the request. I also agree that Lebanon Valley Dragway and any third party they choose may use all or part of my video for any and all purposes. I will not receive compensation or credit. I agree not to use all or any of the footage I take in any manner which would or could be competitive with the commercial sale of a video of the event. _____

Restricted Area Photo/Video Armband and Photo/Video Credentials:

A "restricted photo/video armband," consigned by Lebanon Valley Dragway, is required to receive photo/video credentials and to enter the restricted photo/video area. It must be worn at all times and is not transferable. This agreement and the official release and waiver of liability must be signed to receive a restricted photo /video area armband. **Lebanon Valley Dragway reserves the right to approve or deny all photo and/or video credential requests, and revoke credentials, prior to or during any event for any reason at any time.**

Photo/Video Area:

The photo/video area is located behind the retaining wall on each side of the track, extending from the starting line to 100 feet down track (may be marked on the wall and/or by an orange cone). Outside photographers and videographers are not permitted beyond this point at any time. **The only exception to this rule is for the official photo vendor and videographer and/or their employees previously noted in this agreement.** Top end track access is available only by special permission from Lebanon Valley Dragway.

Violation and/or Revocation:

I understand and agree that violation of any part of this policy will result in immediate revocation of privileges at the sole discretion of Lebanon Valley Dragway, and may result in legal action by Lebanon Valley Dragway and/or any third party that Lebanon Valley Dragway authorizes to sell photos/videos of the event.

Permissible Areas:

PHOTOGRAPHERS MUST STAY BEHIND THE RETAINING WALL AT ALL TIMES. Outside photographers are not permitted over the track wall, on the track, at any time during the event. **Do not lean against or over the retaining wall at any time.** Cameras and equipment cannot be mounted on or placed against the retaining wall.

Photographers are not permitted in the "starter's box", starting line or on the racing surface burnout area) at ANY time.

When crossing from one side of the track to the other, walk cautiously BEHIND the burnout area.

I understand that I am not allowed on the track surface or in the starter's box, burnout box, or starting line at any time. _____

Attire:

For access to the trackside photo area, shirts and shoes with closed heels and toes must be worn (no open toed shoes, sandals, clogs, slides, etc.). You will be in front of our Lebanon Valley Dragway fans so you must look presentable and you must act professional at all times. Be respectful of your fellow peers.
